

# SAINT LUCIA

STATUTORY INSTRUMENT, 2017, No. 9

[ 13th February, 2017 ]

In exercise of the power conferred under section 114 of the International Partnership Act, Cap. 12.21, the Minister responsible for international financial services, makes these Regulations:

## **Citation**

1. These Regulations may be cited as the International Partnership (Forms and Fees) (Amendment) Regulations, 2017.

## **Interpretation**

2. In these Regulations, “principal Regulations” means the International Partnership (Forms and Fees) Regulations, Cap. 12.21.

## **Insertion of new regulations 8A to 8G**

3. The principal Regulations are amended by inserting immediately after regulation 8 the following new regulations 8A to 8G —

### **“Notice of failure to submit records**

8A. A notice of failure to submit records under section 86(8) of the Act shall be in the form set out in Form 6A of Schedule 1.

### **Declaration of unaudited financial statement and record**

8B. A declaration of an unaudited financial statement and record under section 86(10) of the Act shall be in the form set out in Form 6B of Schedule 1.

### **Declaration of failure to submit unaudited financial statement and declaration**

8C. A declaration of failure to submit an unaudited financial statement and declaration under section 86(12) of the Act shall be in the form set out in Form 6D of Schedule 1.

*International Partnership (Forms and Fees) (Amendment) Regulations*

**Declaration of receipt of unaudited financial statement and declaration**

8D. A declaration of receipt of an unaudited financial statement and declaration under section 86(13) of the Act shall be in the form set out in Form 6C of Schedule 1.

**Register of contributions**

8E. A register of contributions under section 87(1) and (2) of the Act shall be in the form set out in Form 6B of Schedule 1.

**Declaration of receipt of register of contributions**

8F. A declaration of receipt of register of contributions under section 87(4) of the Act shall be in the form set out in Form 6B of Schedule 1.

**List of failure to file register of contributions**

8G. A list of failure to file a register of contributions under section 87(6) of the Act shall be in the form set out in Form 6C of Schedule 1.”.

**Amendment of Schedule 1**

4. Schedule 1 of the principal Regulations is amended by inserting immediately after Form 6 the following Forms 6A to 6D —
